SPIDER RECORDING SCHEME

Thank you to all the Members of the Spider Recording Scheme for their continuing support and activity. An indication of progress during the past year is contained in the numbers of completed SRS cards that have been sent in:

The enclosed map shows the uneven distribution of RA65 submissions throughout Britain. If a further analysis of records is made, it is clear that in each vice-county there are considerable areas that are practically unrecorded. Vice-county maps, indicating coverage on a 10Km square basis, have been sent to each Area Organiser this year, and they are in a position to tell individual Recorders where there is greatest need for active recording.

UNDER-RECORDED 10Km SQUARES

For the next year or so, S.R.S. Recorders are asked if they will help in the task of making records in under-recorded 10Km squares in their area. The following suggestions might help in planning:

- a. Get in touch with your Area Organiser, who can tell you the areas that require attention. Alternatively, the National Organiser can supply you with vice-county maps indicating the current RA65 coverage - please include a stamped, addressed envelope for your reply.
- b. Refer to 0.S. maps (1:50,000) Landranger Series, to determine the variety of probable habitat in the selected 10Km square(s), and note in particular areas of woodland, heath, bog, coast, quarry, etc.
- c. Record spiders in each habitat in your selected square in spring, summer and autumn/winter, perhaps using a variety of collecting techniques.
- d. If your Area Organiser is working along these lines, please help him all you can. If you are tackling the problem independently, it might be wise to inform your area organiser so as to avoid duplication.

Last year, the national organiser tried out this technique in a square in East Yorkshire for which no previous records existed; by the end of the year, just over 150 species of spider had been recorded.

AREA ORGANISERS

An up-to-date list of Area Organisers, with their areas of responsibility and their addresses is included in this Newsletter. Please note the considerable number of changes that have occurred since the S.R.S. was founded in 1987. Completed cards should normally be sent to the appropriate Area Organiser, but in the case of scattered records (as you might obtain while on holiday) the cards may be sent direct to the national organiser.

The S.R.S. and the B.A.S.

The British Arachnological Society can be regarded as the parent body of the Spider Recording Scheme, while the Biological Records Centre at Monks Wood plays a complementary and equally important role in the activities of the S.R.S. At a Council Meeting of the B.A.S. held at Losehill in Derbyshire in April 1990, a brief discussion developed on the role of the S.R.S. in the context of the over-all activities of the B.A.S. and the following points are among those that arose from the discussion:

- a. On the assumption that the proposed Atlas of British Spiders (in 1997) is to be associated with the B.A.S. it was agreed that the latter should pay a more positive role in forwarding the work of the S.R.S. Of the 250 British members of the B.A.S., only 85 are S.R.S. recorders, and there must be a lot of information held by B.A.S. members that is not at present available to the S.R.S. It was agreed to publicise the S.R.S. more widely in B.A.S. Newsletters and in other information outlets.
- b. Dr Steve Rushton, a B.A.S. Council Member, agreed to help with the production of the S.R.S. Newsletter.
- c. Mr Craig Slawson agreed to act as adviser on computer recording by S.R.S. members. He will develop a policy in conjunction with Mr Brian Eversham of the B.R.C. Monks Wood, so that computer records submitted by recorders can be checked for accuracy of identification, completeness of data, etc. Attention will also be paid to the compatability of computer systems.
- d. The B.A.S. agreed to make a small annual grant towards postal and other expenses incurred by the S.R.S. At present, the B.R.C. meets all expenses concerned with the production and distribution of the S.R.S. Newsletter, the printing and distribution of record cards etc.
- e. Consideration is to be given to the possibility of producing four Newsletters a year, with the contents more widely based than previously. Recorders are therefore invited to send short contributions for future Newsletters on matters directly concerned with spider recording in its broadest sense.

S.R.S. WEEKEND COURSE IN THE FOREST OF DEAN.

After the successful weekend course last summer in Northumbria, this year's course is being held on the weekend of September 14th to 16th at Littledean House Hotel, Littledean, Forest of Dean, Gloucs. GL14 3JT (tel. Dean (0594) 22106). Already 20 people have booked and there is still room for more. Full board and lodging from Friday dinner to Sunday afternoon will cost about £40 per person.

Gloucestershire is a county where little spider recording has been undertaken and it is planned to divide the S.R.S. party into small groups to cover as many sites as possible on the Saturday and Sunday morning, but on Saturday evening there will be an opportunity to discuss S.R.S. matters or to exchange views on collecting techniques, identification problems, etc. Please book through Mr Francis Farr-Cox of 1 Winchester Road, Burnham-on-Sea, Somerset TA8 1HY (with a deposit of £10.00 per person) as soon as possible, or direct to the hotel mentioning that you will form part of the S.R.S. party.

THE USE OF GEN7 CARDS

An increasing number of recorders are using GEN7 card (each card records a single species, taken from a number of sites on a number of occasions). These cards should not replace the use of RA65 that are concerned with recording all species taken at a single site on a single occasion. GEN7 cards are most useful to record isolated observations, and can be cumulative over a number of years. They are often used for extracting historical records from journals, or recording specimens in a museum collection.

Why not start a set of GEN7 cards and send them in when data for the proposed Atlas is to be sent to Monks Wood? Cards for this purpose should be ordered direct from Mr Brian Eversham, Biological Records Centre, Monks Wood Experimental Station, Abbots Ripton, Huntingdon, Cambs. PE17 2LS.
